## Burning Reminders:

- ◆ Recreational fire pits are not to exceed 4 ft. diameter and may not be less than 25 ft. from any structure. The burning must consist of clean wood ONLY.
- ◆ Burning yard waste can take place noon till 8:00 pm, from Monday through Saturday.
- ◆ No burning allowed on Sunday.

**Also:** On Tuesdays, brush & garden waste will be picked up at the curb. Containers must be less than 50 pounds.
